Sales

Every effort will be made to encourage sales. The Tewksbury Historical Society will retain a 30% commission on the sale of any and all juried works, Small Works and Portfolio Showcase pieces. Sale prices may not be changed after entries have been submitted. Payment to artists may take up to 30 – 45 days. **All juried artwork must remain on premises for the duration of the exhibition.**

A Short History

Established by the Historical Society in 1989 to preserve Tewksbury through artwork exclusively depicting Tewksbury Township subjects, the “Tewksbury Art Show” has expanded its scope while retaining its original spirit. The show encompasses juried, small works and portfolio Areas.

Jurors

Judge of Selection: Gerry Heydt

Gerry has a BFA from Stephens College, Columbia, Mo., in fashion illustration, and an MFA from the Instituto Allende affiliated with the U. of Guanajuato, Mexico, in drawing and printmaking. She has studied at the Pratt Graphics Center in NYC, where she completed her master's thesis. She began studying oil painting in 1987 with James McGinley at the Newark School of Fine and Industrial Arts and also with Sam Adoquei at the N Y Academy of Figurative Art, the Natl. Academy of Design in NY, and at his Union Square studio. Gerry lives and works in Plainfield, NJ.

Gerry is known for atmospheric, boldly brushed plein air and studio landscape paintings of New Jersey's natural areas as well as of the northern Maine Coast. She has been teaching oil painting classes and workshops at the Visual Arts Center of NJ, Summit since 2002, and has given lectures and oil painting demos to multiple NJ arts organizations. Her work has been widely exhibited in the tri-state area, including with NJ land conservation organizations. Her paintings are included in author and environmental scientist Judy Auer Shaw's “The Raritan River, Our Landscape, Our Legacy”, Rutgers University Press. Heydt has had retail gallery affiliation in NY, NJ, and PA since the 1990's; her work is in collections in the USA and Europe. She works both outdoors on location and in her studio at The duCret School of Art in Plainfield.

Judge of Awards: Charlie Churchill

Charlie Churchill has an MFA from The New York Academy of Art in New York City and undergraduate degrees from Parson's School of Design and Lafayette College. For 15 years he was an Art Director and Illustrator at Gigante Vaz & Partners advertising. Charlie has participated in numerous group shows in New York City and New Jersey over the last 15 years winning awards, grants, and corporate commissions. His work hangs in private and corporate collections throughout the United States and Europe. He has taught drawing and painting at Lehigh University in Bethlehem, PA. He has executed numerous paintings for The New York Health and Hospital Corporation over the last decade, recently finishing a series of canvases for the Elmhurst Hospital Center for their new Express Care Wing, a portrait for Morristown Medical Center's AFIB Conference Room, and a portrait of US Olympic Hurdler Sydney McLaughlin that now hangs in the Union Catholic H.S. Hall of Fame. The artist teaches at The Center for Contemporary Art in Bedminster, NJ, and privately throughout NJ.

Eligibility of Juried Work

- Artists must be a minimum of 18 years old
- Each artist may submit up to 5 works to be juried
- No work may exceed 40” in any direction – **only one 40” submission per artist**
- Paintings on stretched canvas may be presented framed or unframed, and wired – ready to hang
- Painting on canvas board must be framed and wired-ready to hang
- Works on paper including photography must be matted, framed, glazed with glass or Plexiglas and wired - ready to hang

Eligibility of Juried Work contd.

Artists are encouraged to submit work to the “Small Works” area as well as the “Portfolio Showcase”.

ALL artwork must be labeled for sale.

Juried Work Media

Must be original artwork **not previously submitted to this show!**

Works completed in any 2 dimensional media (including photography) may be submitted.

No giclees allowed.

Small Works and Portfolio Procedures

Artist MUST have submitted at least one juried piece to be eligible for the “Small Works” and Portfolio areas of the exhibition. (Not eligible for awards)

List of Works for Sales Records:

Provide 2 copies letter size list of works:

- **Artist Name and Phone No. on top of page**
- **List No., Title, Price of each work**

Data to be affixed to the front of the work (do not affix labels to gilded/painted frames):

Artist Name, Price and List No./Title of Work

Eligibility of “Small Works”

- Up to 5 pieces may be submitted
- **Frame** measurements no larger than 14” x 18” (Properly framed, glazed & **wired-no saw-tooth hangers**)
- Marked for sale: Mark price, artist name, # of piece on the front of work (**do not affix labels to gilded/painted frames**)
- Small Works must be brought in an appropriately sized sturdy box labeled with the artist's name
- Prices of “Small Works” may not exceed \$250.

Eligibility of “Portfolio Showcase”

- Up to 10 portfolio pieces may be submitted
- Artist must supply a professional **floor standing-print rack** for the pieces
- Portfolio pieces may not exceed the outside dimensions of the portfolio
- Each piece must be professionally presented and labeled to match List as required above

Liability Clause

Entries and artwork will be handled with all possible care. However, the Tewksbury Historical Society and the Zion Lutheran Church will NOT be responsible for any loss or damage that might occur. We advise you to insure your own artwork.
